## MORRIS PRATT INSTITUTE ASSOCIATION STUDENT POLICY STATEMENT

1. A detailed outline of the Correspondence Course of Study on Modern Spiritualism is available and should be studied carefully by the prospective student. Any further questions may be directed to the Secretary of the Morris Pratt Institute Association.
2. The Morris Pratt Institute Association, Inc. admits student of any race, color, sex, age, handicap, and national or ethnic origin.
3. Students of this Course are expected to complete the work within five (5) years from the date of enrollment unless granted an extension by the MPI Secretary to continue. Failure to do so may result in the withholding of the issuance of the Certificate of Completion by the Morris Pratt Institute Association. Requests for extensions must be received in writing.
4. Morris Pratt Institute Association reserves the right to withhold sending further lesson material in the event the student's financial account is not current. The Morris Pratt Institute Association reserves the further right to cancel a student's enrollment in full if the account is in default for a period of ninety (90) days or more. Such cancellation shall become final upon written notification by mail addressed to the student's last known address.
5. Morris Pratt Institute Association reserves the right to add a surcharge to each course sold to defray the cost of future increased postal mailing rates, materials, or handling costs.
6. Morris Pratt Institute Association will charge a twenty dollar (\$20) fee for any returned check.
7. Certificates of completion will be issued by the Morris Pratt Institute Association to the student who **satisfactorily** completes course work in the following categories - Mediumship, twenty-two (22) lessons - Spiritualist Healer, fifteen (15) lessons - Licentiate Minister, thirty (30) lessons. **Satisfactory completion** is defined as a grad of seventy-five (75%) for each lesson completed. Unsatisfactory answers, at the discretion of the examiner, may be returned to the student for further work.
8. Morris Pratt Institute Association requires the signature of a parent or guardian of anyone under the age of eighteen (18) years applying for the course.
9. Morris Pratt Institute Association will allow no transfers of funds to another student after a five (5) year period. Processing fees will be deducted from any transfer requested, at a rate to be determined by the MPI.
10. Morris Pratt Institute Association will allow no refunds on the course after 30 days of the date of purchase. If course is in new condition, the cost of the course will be refunded minus application and administration fees.
11. Morris Pratt Institute Association gives no discounts to married couples, family members, or members of the same household.
12. Morris Pratt Institute Association is an educational school and as such grants only **Certificates of Completion** to be presented to your affiliated Association for their testing process. It is the student's responsibility to know if the Morris Pratt Institute Association is an approved course of study for their Association. Morris Pratt Institute **Does Not** grant final certifications or ordination.
